Competitions open to AIRC members only. Membership numbers must supplied with entries & cards produced on the day,prior to competing.

You must enter at your cross country grade.You may not transfer class on day of competition.

Entry fees:One Day Event €50, Combined training €30.

Schedule.

Class 1:Open/Advanced Open – BE 114(2009)

Class 2:Advanced Intermediate -BE 101(2009)

Class 3:Intermediate-BE 92(2009)

Class 4:Adv Open/Open/Adv Int B – BE101(2009)

Class 5:Young Horse-BE 91(2009)

Class 6:Advanced Primary – BE 91(2009)

Class 7:Primary Combined Training – BE 100 (2001)

***Class 4** is for riders above intermediate level who do not wish to compete at their own grade. This may be for various reasons such as aged horse, loss of nerve etc. This class will be run over the intermediate track.

Young Horse Class is open to riders of Advanced Intermediate or higher, horses 4 & 5 years as stated on the animals passport , in their first year of competition.

Rules will be as for eventing ireland with amended speeds for grades.

Entries Close Monday 4th July.

No late entries will be accepted. Fees must accompany all entry forms.

Timing Devices

Timing devices including stopwatches are banned from use in Advanced Primary and Intermediate cross-country competitions including cross jump. Competitors who are found in possession of a timing device will be eliminated from the competition.

There will be no refunds for withdrawals after 6th July for entries. Border Counties Riding Club reserve the right to cancel any class due to insufficient entries.

Rules and Conditions.

All competitors must be AIRC Members, competitors must present themselves with their card and horse passport to collect their numbers before competing.

The landowners, their agents nor the organisers shall accept any liability for any damage, loss or accident to any person whether spectator or competitor, to any animal, vehicle or property, howsoever caused in connection with this event.

The committee reserves the right to refuse any entry.

Competitors who, in the opinion of the officials, are unsafe will not be allowed to continue to the next phase.

Safety officers and stewards are there for the protection of all members.

They give their time freely, so please obey them at all times and show consideration to all officials. Failure to obey instructions or requests of stewards will be subject to AIRC disciplinary action and immediate elimination from the competition.

Competitors must report to the call up steward at each phase with ample time to allow for tack inspection. **It would greatly assist the tack stewards if hats could be presented when collecting numbers, once this is done hats can be tagged and will not need to be removed for checking.**

Competitors must run in numerical order.

The organisers reserve the right to combine or divide or cancel any class depending on entries.

Riding Hats / Body Protectors

It is compulsory that riding hats/skull caps conform to the following standard(s):
EN 1384 (it is strongly recommended that it is prefixed by BS (British Standard) or,
PAS 015 (1998) or,
ASTMF 1163-95 or,
ASTM Snell E95 (SEI)

The identifying label must be stitched into the lining by the manufacturer of the helmet. Skull caps are compulsory for cross-country. These hats/helmets must always be worn correctly fastened when A.I.R.C. members are mounted at Riding Club activities and competitions.

Level three (purple) or higher body protectors are compulsory for cross-country events. It is recommended that body protectors are also used whilst show jumping

Competitors must wear a correctly fitted Hunting tie /stock or neck support for cross country.

Competitors must have their own number bibs and medical armbands.
